- manage traditional and new techniques and technological procedures, choose and defend the most appropriate procedure of the implementation of visual design, continuously evaluate the quality of the results of partial working operations;
- work out model of a furniture object, interior or part thereof, according to artistic design in the given scale;
- decide on the use of corresponding machinery, equipment, tools, instruments and devices for the business operations;
- manage basic economic activities in relation to the anticipated professional life;
- present the work appropriately depending on the specific situation.

The graduate is employed especially as a creative or technical/organisational worker in areas focusing on interior design including accessories and their realisation.



He can be employed as designer in teams of furniture and interior design studios and ateliers in consultancy activities for interior architecture.

He can also find a position in the management of small working teams in companies producing furniture.
